The Healthy Harvest Food Bank provided supplemental food to 11,183 people monthly in the six-county territory of Lancaster, Northumberland, Richmond, Westmoreland, Middlesex and Essex. HHFB distributed over 2.1 million meals to 36 pantries and meal sites. The following programs were offered to those in need in our region:

-Core distribution consists of delivering food (40% produce, 40% non-perishable, 10% meat and 10% bakery/dairy food items) to our partner pantries.

-Backpack Buddies (weekend meals) to over 841 students in need.
